

# Commentaries on Thomas Dalton introduction to Mein Kampf.



## Introduction

I would like to address several points brought up by Dalton in his introduction.

I would agree that:

Hitler had visions, ideas, expectations-which turned out to be stunningly accurate. His powers of perception and foresight were astonishing.

Mein Kampf is a remarkable anticipation of things to come. Hitler's vision and worldview were realized more quickly than even he could have thought possible. This is tangible proof of the power of ideas to remake the world, when accompanied by a sense of greatness and higher purpose. Such things are utterly lacking in the world today, and thus they seem strange, odd, and even frightening to us. We forget that, for much of our history, these ideas were the very means by which nations and cultures thrived.

The parallels to the present day are striking. The triumph of a **Marxist/Liberal** Jewish-inspired worldview. In America, he would find **Marxist/Liberal** Jewish leadership in all major media organizations and film studios; Jewish money decisive (I would say play a disproportionately material role) in all national political races; The present Biden's administration consists almost entirely of **Marxist/Liberal** Jews. A Secretary of State, Treasury, Homeland Security, Attorney General, Chief of Staff and the scores of others in the less senior positions (see Jewish Virtual Library). This is unprecedented in the history of the USA. There is also the most incompetent administration in the history of the USA. I would agree with Trump that they hate America.

I would like to raise several objections.

## Main point

The main point of all anti-Semites is that Jews are under central command or represent one unit. This could not be further from the truth. Just take a look at Eric Zemmour, a Jew, who is trying to unite the patriotic forces of France against **Marxist/Liberal** / **Woke** Jewish poison or Mark Levin in the USA. They are treated as antichrists by the Liberal/Marxist Jewish legacy media like the New York Times.

On page 32, Dalton points out several Hitler's conclusions/observations regarding Jews in Vienna that led to Hitler's anti-Semitism. They (people in caftans) were physically and visually repellent (subjective). They smelled bad. This may be true regarding some ultra-orthodox Haredim/Hasidim Jews. What is the proportion of Haredim/Hasidim to assimilated Jews in Vienna? I doubt that ultra-orthodox constituted the majority of Jews in Vienna. Assimilated Jews were not that different in hygiene and didn't dress that differently than locals. Hitler's/Dalton claim that these Jews seem to endorse a "strange" ideology: Zionism is laughable. In fact, Haredim/Hasidim (except Lubavitchers) are ardent anti-Zionists. Also, what is so strange about this ideology/movement is not explained by Dalton or by Hitler. Anecdotal, this "strange" ideology advocating Jewish repatriation to the Palestine would alleviate Hitler/Dalton from "moral rot" and bad smell.

Claims of Jewish (I would add **Marxist/Liberal Jewish**) "moral rot" and negative impact on culture and society are somewhat true. Some, mostly Liberal/Marxist Jews have had disproportionate negative impact on culture and society. Was "moral rot" limited only to Jews? Have all these negative things disappeared in Hitler's Reich and post war Germany, when there was a minimum number of Jews left. Plenty of artistic trash and theatrical idiocy in post war Germany. As to Arian "moral rot" just take a look at a complete moral degenerate Julius Streicher, who was embraced by Hitler and despised by all Nazi

leadership. Or I can point to Konrad Morgen (top SS judge/investigator) investigations. Plenty of “moral rot” among SS higher ups and regular members.

## Another point

Another point is that Jewish Marxists and capitalist are joint, which is nonsense. How many wealthy Jews in Russia retained their capital/property after the Bolshevik Revolution? Name one. The phrase “Loans used to extract wealth from masses.” is worth noting. It could be taken right from Marx writings. I guess Hitler/Dalton and Marx have similar views. Total economic illiteracy. Economy cannot function without interest-bearing loans. Interest rates are regulated.

There is a claim/complain/accusation of Jewish domination/overrepresentation in Vienna. (page34). Some statistics are given. However, how was 1.09% determined? Were half-bloods or quarter bloods included in 1.09%? Were half-bloods and quarter bloods included in the overrepresentation numbers? 50% of the theater directors were Jewish. Were the non-Jewish directors’ productions better? If yes, who prevented non-Jewish locals to attend non-Jewish directors’ productions. Same in metal businesses.

Jews were responsible for the November Revolution in Germany and in part for the defeat in WW I. The war was lost way before November. I guess Jews forced German General [Erich Ludendorff](#), chief architect of that final spring offensive, to demand at a crown council meeting on September 29, that Germany seek an immediate armistice based on the terms President Wilson had laid out in his famous Fourteen Points address in January 1918. Defeat on 8/8/1918 and allied offensive was apparently also orchestrated by the Jews. I guess that Jews were responsible for Kaiser and his cabinet’s incompetence, thus dragging USA into a war on allies’ side.

Based on what facts were the unnamed Jewish profiteers on war, corruption, immorality, exploitation, deception were fanatical Zionists and what did it have to do with the creation of the Jewish state. “The facts are what they are.” Where are these facts? How were Prussia and united Germany built? Through peace negotiations?

Hitler argues that the killing of 12000-15000 Hebrew corrupters at the start of the war would lead to a German victory. Any facts of Hebrew corrupters interference in Von Moltke the Younger handling the first battle of the Marne.

On page 35 Dalton states that Hitler never talked of mass murder, thus, proving Hitler’s peaceful intentions. Neither did Stalin, which does not mean anything.

Roosevelt “unwise” decision to harass Germany into war was a major blunder? On the contrary, Hitler’s decision to declare a war on the USA is considered to be his main mistake that led to his downfall. Was Churchill ruled by Jewish Marxists and capitalists? I doubt it.

As to the Holocaust denial.

Dalton explanation is “undeniable and tragic death of several hundred thousand Jews” mostly by accident. I guess, they happen to pass by Babiy Yar and decided to commit suicide. Nearby stationed Germans and their local accomplices dig out a ravine only out of compassion. Or another explanation: “And a forced labor camp in which thousands of Jews died from typhus— Auschwitz”. Is forcing people in

a labor camp where they die from typhus not genocide? My grandparents along with their family were forced into Ghetto during Nazi/Romanian occupation of Ukraine. Most members of their families died from disease, starvation, etc. How is it different from gas chambers? Watch the Nazi propaganda movie Theresienstadt. What happened to the Jews in the movie? How many survived including the Jewish director. I guess they all committed suicide. The Wannsee Conference is all fake? What if only 4,000,000 were killed. Does it make a difference? Dalton whitewashes crimes and defends indefensible. Sometimes some ethnicities may decide that they don't want to coexist with another. Why not try a civilized divorce. But physical extermination?

Dalton brings up typical anti-Semitic boogeyman – AIPAC, its tactics specifically. But he stays silent on what is wrong with their tactics. Same with the role of the Jewish lobby. What is the definition of Jewish lobby?

“Judenknecht Merkel, who allows that once-great nation to be flooded with a mass of foreign ethnicities, even as she pays monumental Holocaust reparations to the Israeli state. “Most of these ethnicities are Muslim and hate Jews. How does this serve Jewish interests? What monumental reparations? What is the amount? Which European nations signed to fight Israeli wars? In what capacity? In fact, all European Union does is to sabotage Israel, who has enough capacity to destroy its enemies many times over.

Regarding Thomas Dalton New English translation. It may be better than the previous works but unlike Russian translation it still does not convey the fluidity and lyrical power of the German original.

Two examples:

- a. 2.16. SINS OF THE BOURGEOISIE (p. 80) - “refusal to consider protective measures for women workers, especially pregnant ones”. The original is something like that: women who carry a son of the fatherland (or a brother or a comrade) in their womb. Totally different lyrical power.
- b. 11.10 SHAM CULTURE OF THE JEWS (p.305) – “acting” – “dramatic art” in the original and one previous translation. Again, much broader meaning with different lyrical power.

## Conclusion

I would like to end my commentary with the Soviet/Jewish joke. An old Jew with a heavy Jewish accent calls Moscow based society “Memory” (notorious anti-Semitic organization).

-“Is this “Memory society” (pamyat in Russian).

-“Yes.”

- “Is that true that Jews sold out Mother Russia.”

—“Yes, it's true, you hooked nose Jewish mongrel”.

-“Please advise me where can I get my share?”
